# INFORMATION ART. 13 - REGULATION (EU) 2016/679 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of April 27<sup>th</sup> 2016 on the protection of individuals

#### 1. Introduction

According to the law, the processing of data will be based on principles of correctness, lawfulness, transparency and protection of your privacy and your rights.

In accordance with Regulation (EU) 2016/679 of April 27<sup>th</sup> 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, we inform you as follows.

## 3. Type of data subject to processing

- Section 5 (c) is necessary to comply with applicable laws and therefore the refusal to provide the Data would prevent the conclusion of the aforementioned contract / act of participation or, if already concluded, to continue its execution.

## 7. Scope of communication and dissemination

The Data will be accessible only by duly authorized employees to whom the Company provides access to the Data to the extent necessary to perform their company duties.

The company may transfer your data, registered for the reasons set out in sections 5 (a) and 5 (b), to the partner FIERA di ROMA s.r.l., with sole shareholder, (P.I. 07540411001) registered office in Rome, Via Portuense n. 1645/1647, as foreseen in the regulation in the "international festival of comics, animation, cinema and games" (aka Romics) delivered to you along with the related Privacy Policy provided by the FIERA di ROMA itself s.r.l. pursuant to art. 14 GDPR.

The Company may disclose the Data referred to in Section 5 (a) to third-party service providers in charge of processing Data and, where required by applicable laws, appointed as data processors (e.g. cloud service providers, services that are instrumental to the activities of the Companies, such as, but not limited to, companies providing IT services, experts, consultants and lawyers, companies resulting from possible company mergers, spin-off or other transformations) and Section 5 (b) to the competent authorities, where permitted by applicable laws.

#### 8. Transfer of data to third countries

Personal data will not be transferred to third countries.

#### 9. Rights of the Data Subjects:

In relation to the data subject of the processing referred to in this information, the data subject is granted at any time the right to:

- Access (art. 15 EU Regulation n. 2016/679)
- Correction (art. 16 EU Regulation n. 2016/679)
- Cancellation (art. 17 EU Regulation n. 2016/679
- Limitation (art. 18 EU Regulation n. 2016/679)
- Portability, understood as the right to obtain data from the data controller in a structured format commonly used and readable by automatic device to transmit them to another data controller without hindrance (Art. 20 EU Regulation No. 2016/679)
- Opposition to processing (Art. 21 EU Regulation No. 2016/679)
- Withdrawal of consent to processing, without prejudice to the lawfulness of the processing based on the consent acquired before the revocation (art. 7, par. 3 EU Regulation No. 2016/679)
- Lodge a complaint with the Data Protection Authority (art. 51 EU Regulation No. 2016/679)

The data will be stored for a period not exceeding that necessary for the purposes for which they were collected or subsequently processed in accordance with the provisions of legal obligations.

# 12. Consent to the processing of personal data for the further purposes set out in Section 5 (d)

For personal data processing for the further purposes set out in Section 5 (d), the Company requests consent, only for the specified purposes, by signing the following declaration. In the absence of explicit consent to the processing of the aforementioned data, participation in the event or the stipulation and / or execution of the relative contract / application for participation may not be prejudiced; however it may prevent the provision of some services promoted during and after the fair. The right to withdraw consent at any time is granted without prejudice to the lawfulness of the processing carried out before revocation.
