The place dedicated to self-productions

RULES

1. The **Self Area** is an exhibition space dedicated to **self-produced comics, illustrations, board games, and card games**. To be admitted, it is necessary to have self-produced at least one product by the date of registration.
2. You can register as an **author** or a **collective**. Joint participation is permitted exclusively as a collective, defined as a stable group that creates and self-produces works under the collective's name. Sharing space between distinct authors not part of a structured collective is not permitted.
3. **In the Self Area is allowed:**
 - display and sell self-published comic books and graphic novels;
 - display and sell your art books, original drawings, original works, or self-produced sketches;
 - display and sell gadgets inspired by your self-productions and fanart;
 - promote or present unedited comic stories that will then be self-published;
 - displaying and selling self-published board games and card games, not marketed in large-scale distribution.
4. **The goods** on display must conform to the products declared in the application, any product not previously indicated or not conforming to the description may be removed.
5. **The registration fee** (€ 250,00 + VAT) for the four-day event includes:
 - N.2 tables (dimensions cm 120x67x72h)
 - N° 2 Chairs
 - N° 2 Exhibitor passes
 - N° 1 Car pass
 - Shared electricity in the area
 - For participants presenting board games or card games, additional shared tables will be provided in the area, strictly for the demonstration use of the proposed games.
6. **Setting up and dismantling**
 - delivery of the space shall take place from 8.30 a.m. on the day before the start of the event (8/04/2026). All set-up operations (banners, rollup, etc.) are the responsibility of the artists and must be completed by 8.00 p.m. on the indicated day. Participants must occupy the stands and keep them equipped and set up for the entire duration of the event. Additional tables are not permitted, space is calculated based on the stands.
 - The dismantling and related disassembly operations will take place on Sunday 12 April from 21:00 to 24:00, with a discharge of liability for any materials still inside the occupied area after the indicated time.
 - Admitted participants will receive access credentials for their reserved area in the Exhibitors' Manual of Fiera Roma. Within the portal, it will be necessary to carry out pre-accreditation to gain access on set-up and dismantling day. Within the portal, it is possible to purchase car passes or extra exhibitor passes.

7. **Exhibitor Passes and Car Passes:** on the set-up day, at the Organiser's Secretariat, it will be possible to collect the included Car Pass valid for the four days of the event. The exhibitor passes are nominative and digital: the contact person will receive the link to enter the names and issue the exhibitor passes.
8. The selection of suitable entities for the Self Area will be at the sole discretion of the organisation, subject to availability.
9. The organizers define the layout plan of the stations and are responsible for the allocation and placement of each station.
10. The organisers expressly reserve the right to change the allocation of places without the participants being able to claim reimbursement of the fee or compensation for any reason whatsoever.
11. In the event of non-compliance, the organisation reserves the right to prevent the author's participation in the event, also reserving the right to claim compensation for damages resulting from the non-compliance.
12. The stations must be kept in a visible and accessible condition.
13. By signing the application form and in the event of acceptance, the author undertakes to participate in the event at the assigned station and to accept these regulations without reservation, as well as to comply with the safety regulations that will be communicated by the Fair organisation.

REGISTRATION

1. To register, you must complete the online form by **15 February 2026**.
2. By **23 February 2026**, the outcome of the application and the registration form to formalize participation will be sent.
3. On receipt of this confirmation, participants must send the completed application form to commerciale@romics.it by **6 March 2026** at the latest and attach the receipt of payment of the balance of the participation fee. If the author does not attend, the fee paid will not be refunded.
